Be sure to show your work clearly! Then determine which option is the best for Jennifer. Jennifer will be able to go to college 15 years from now.

| Option One: An account that earns an annual interest of 2.34\% compounded monthly. | Option Two: An account that earns an annual interest of 2.5\% compounded quarterly. | Option Three: An account that earns $\$ 150$ each year. | Option Four: An account that earns an annual interest of 2.43\% compounded continuously. |

| I know I need to use the compound interest formula since option one earns interest monthly. 1 know $A_{0}=5000$ because the initial amount of money invested was \$5000. 1 knowr $=.0234$ because the interest rate is $2.34 \%$ which is .0234 when written as a decimal. 1 know $n=12$ because the interest is compounded monthly which is 12 times a year. 1 knowt $=15$ because jennifer goes to college 15 years from now. Therefore, $A(15)=5000\left(1+\frac{.0234}{12}\right)^{12(15)}$ <br> Jennifer would have $\$ 7100.01$. | I know I need to use the compound interest formula since option two earns interest quarterly. 1 know $A_{0}=5000$ because the initial amount of money invested was $\$ 5000.1$ knowr $=.025$ because the interest rate is $2.5 \%$ which is .025 when written as a decimal. 1 know $n=4$ because the interest is compounded quarterly which is 4 times a year. 1 knowt $=15$ because Jennifer goes to college 15 years from now. Therefore, $A(15)=5000\left(1+\frac{.025}{4}\right)^{4(15)}$ <br> Jennifer would have $\$ 7266.47$. | I know I need to use a linear equation $(y=m x+b)$ because option three is earning a constant amount of money per year. I know $m=150$ because the account is earning $\$ 150$ per year. 1 know $b=5000$ because the initial amount of money invested was $\$ 5000.1$ know $x=15$ because Jennifer goes to college 15 years from now. Therefore, $y=150(15)+5000$ <br> Jennifer would have $\$ 7250$. | I know I need to use the compounded contínuously formula since option four earns interest <br> continuously. 1 know $A_{0}=$ 5000 because the initial amount of money invested was $\$ 5000.1$ know $r=$ .0243 because the interest rate is $2.43 \%$ which is .0243 when written as a decimal. 1 know $=15$ because jennifer goes to college 15 years from now. Therefore, $A(15)=5000 e^{(.0243)(15)}$ <br> Jennifer would have \$7198.97 |

Option four is the best option for Jennifer because it would give her the most money in 15 years.
